- (1) the policyholder will verify the address of the member
- (2) the original driving licence of the member is inspected by the policyholder
- (3) membership is not open to and the car will not be driven by anyone described below:-
 - a) Drivers aged 20 or under
 - b) Drivers aged 24 or under when the vehicle being hired has a seating capacity of 9 or more, in addition to the drivers seat
 - c) Drivers who have held a full licence for the class of vehicle being hired for less than 12 months
 - d) Drivers who have been involved in more than 3 accidents in the last 3 years
 - e) Drivers who have been involved in more than 2 theft claims in the last 3 years
 - f) Drivers who have been convicted of the following offences: UT50, CD40, CD50, CD60, CD70, CD71, DD40, DD60, DD80, DR10, DR20, DR30, DR31, DR40, DR50, DR60, DR61, DR70, DR80 or DR90
 - g) Drivers who have been disqualified for a period exceeding 6 months in the last 3 years and drivers who have been disqualified for a period exceeding 3 months during the past year
 - h) Persons who have had their insurance declined and/or renewal refused and/or special insurance terms imposed as a result of claims experience and/or have had their insurance or cover cancelled by any Motor Insurer.
 - i) Provisional Licence Holders
 - j) Persons engaged wholly or partly in professional entertainment, professional sports persons, modelling or itinerant workers
